

Thank you for your interest in residency at Next Chapter Ministries. At NCM, we have homes for men transitioning back into the community from incarceration from both county and state facilities. These homes, called Discipleship Homes, make up our Christian-living residential program for men where we take a holistic approach to support men through day-to-day life after incarceration.

A disciple is one who comes under the learning and guidance of another. We desire for our Discipleship Homes to assist, equip, and support men through teaching, modeling, and daily life together. We believe this model of re-entry can begin to address the roots that led to the cycle of incarceration and make way for deep, holistic, and sustaining change outside of systems.

Discipleship Home residents commit to staying in the homes for a minimum of 6 months and may stay up to 18 months. Through weekly Bible studies, peer-led support groups, meals, counseling, activities, and life together in a safe and healthy community, men can gain an understanding of Christian doctrine, rebuild family



relationships, begin to heal from past traumas, grow in their strengths, and learn to disciple others. Upon completion of the Discipleship Program, men may apply for residency in our Transformation Home for an additional year, to strengthen the foundation established in the Discipleship Home and work to complete our Pathways to Sustainable Housing Program. At NCM, we are looking for men that have a desire for a new way of living, that are willing to be led, and that will be patient with the process.

To apply for residency, please be sure to complete and include the following pieces:

- 1. Fill out Discipleship Home Application out completely
- 2. Carefully read and sign the Discipleship Home Commitments page
- 3. A letter sharing life experiences that have shaped who you are
- 4. A letter of recommendation from a caseworker, counselor, job supervisor, pastor, chaplain, or peer

When completed, send either by email to Office@NextChapterRochester.org or by mail to P.O. Box 9321 Rochester, MN, 55903. After we have received your four pieces, we will review your application and contact your caseworker to plan out the next steps in the process, which may include an interview.

We would also like to note that we are Christ-centered organization and have a lasting commitment to being directed by the truth of the Bible. We want you to be aware that this organizational commitment shapes the culture, activities, and guidance you would be participating with as a resident. But please also know that being a Christian is not required to apply for residency and does not increase your potential of acceptance into residency. Feel free to share openly on your application & letter. We value honesty, welcome vulnerability, cherish those searching for truth in life, understand complexities with challenging pasts in churches and religions, and are accepting of wherever you may be on your faith journey.

Discipleship Home Commitment

"And I am certain that God, who began the good work within you, will continue his work until it is finally finished on the day when Christ Jesus returns." Philippians 1:6

"Therefore, since we are surrounded by such a great cloud of witnesses, let us throw off everything that hinders and the sin that so easily entangles. And let us run with perseverance the race marked out for us, fixing our eyes on Jesus, the pioneer, and perfecter of faith. For the joy set before him he endured the cross, scorning its shame, and sat down at the right hand of the throne of God." Hebrews 12:1-2

If accepted as a resident of the Discipleship Home:

I commit to living and participating in the home for at least six months and may be offered residency for up to one year. Participation is a commitment to being actively involved in the day to day life, relationships, activities, and responsibilities of Next Chapter Ministries. This intentional participation, of both giving and receiving, will help to make The Discipleship Home a strong home for all who live there now, as well as for future residents.

I commit to accomplish and stay on pace with the goals and expectations laid out in each phase of the Discipleship Map. This outline will provide specific objectives, opportunities, accountability, and direction that will assist me in my reentry and restoration. I understand that my progress will be evaluated throughout my stay to ensure my residency is purposeful and fulfilling in regards to restoration to God, family, and community.

I commit to engage with residents, staff, volunteers, and participants of NCM with honoring speech, interactions, and conduct whether they are present or not. I will strive to humbly value others by not just showing care for my interests, but to also care for the interests of others involved at NCM.

I commit to not working during the first three weeks of my residency to accomplish specific items within the Discipleship Map. This intentional time will be used to prepare a solid foundation to be built upon for the rest of my residency. At the beginning of my fourth week of residency, I commit to working a full-time job or attending school.

I commit to paying \$300.00 after my first month of residency and \$500 at the beginning of each month ongoing. There is no financial contribution during the first month of residency.

I commit to participate with financial literacy sessions and to be transparent with my money matters while I am a resident. These sessions will be available to assist and discuss decisions that will impact my financial goals and to help achieve sustainable financial wellbeing during and after residency.

I commit to attend a local church each weekend and to become an active part of that church. I also agree to participate in the scheduled on-site NCM Bible studies, Support Groups, as well as all other learning opportunities provided.

I commit to participating in the care and maintenance of the homes. I will be expected to accomplish these tasks to the standards of NCM Staff.

I commit to being an active participant in the activities and volunteer outreaches of NCM as a practical way to "love my neighbor as myself," to build healthy, lasting relationships, and to take steps to restore myself to the community. The Men's Ministry Staff will set up the activities and volunteer outreaches.

I commit to being in the home by the determined time for evening curfew. I understand that I am expected to stay in the home each night after curfew and that only accepted residents will be in the home overnight.

I commit to not having anyone in the Discipleship Homes without both the knowledge and consent of the on-duty Men's Ministry staff. If given consent by staff, my guests will abide by NCM standards and will remain on the main floor of the home.

I commit to waiting at least six months before engaging in any intimate relationships and to use those six months to learn the characteristics of healthy relationships.

I commit to not using tobacco products or vaporizers of any kind on NCM property. I also commit to completely abstain from the use of alcohol, illegal drugs, abuse or misuse of prescription drugs, all cannabis products, and any other forms of substance abuse. I will be subject to UA's, either at random or if suspected of being under the influence, as a heightened accountability measure and commitment to my sobriety.

I commit to not alter my room or to bring any extra household items (furniture, TV's, etc.) into the home without the consent of the Men's Ministry Staff. Rooms are subject to evaluation by staff at any time. Any personal belongings will not be held for more than thirty days after departure.

I commit to discussing any moving or transition plans with staff at least 30 days before moving.

I commit to following the established rules of NCM and all items in the Resident Manual.

The purpose of this agreement is to detail the expectations of Discipleship Home residents. We are confident that engaging and following through with these commitments will benefit you greatly in your re-entry into the community, all while showing honor to God and your "neighbor". Also, we believe following through with this agreement will help you develop wisdom, discipline, consistency, and perseverance, growing more responsible for the life God has given you.

I have read the Discipleship Home Commitment, and by signing it, I am stating that I desire to live by it as a resident of the home. I know and understand that I am committing to participating as defined in this document. I know that at NCM, I am not alone in my re-entry; there are staff, volunteers, and community supports that will help me in my daily life and to reach my goals. I also know that if I do not follow through with the expectations in this commitment, I will be saying that my desires in life have changed and I may be asked to move out of The Discipleship Home. The decision of the Director is final.
